

## Award in Private Security Guard Services

### Applying for this course:

To apply for this course, you should be 18 years of age up to 65 years of age and have a MQF Level 2 qualification in Mathematics and English and a clean Police Conduct Certificate. ### Course Duration

This course is of 40 hours duration and consists of two Modules

- Module 1 is of 20 hours duration - (including 1-hour assessment)
- Module 2 is of 20 hours duration - (including 1-hour assessment)
