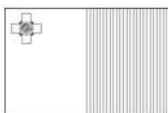

Common Immediate Result Indicators relate *only* to persons and capture the effects on participants brought about by an operation (a project). These indicators capture a change in situation e.g. participants' employment situation. These indicators are to be recorded and stored as individual participant data by Jobsplus.



The results under the immediate result indicators must manifest themselves and be recorded in the time span between the days the person leaves the supported operation (exit date) and the four weeks which follow the event.
